Motion by Councilmember Kells to open the Truth in Taxation Public Hearing, second by Councilmember Bruss. Motion carried unanimously. No citizens were present for the hearing. Motion by Councilmember Lenzen to close the public hearing, second by Councilmember Szaroletta. Motion carried unanimously.

b. PUBLIC HEARING: Fee Schedule Hearing

Motion by Councilmember Kells to open the 2020 Fee Schedule Public Hearing, second by Councilmember Bruss. Motion carried unanimously. No citizens were present for the hearing. Motion by Councilmember Bruss to close the public hearing, second by Councilmember Szaroletta. Motion carried unanimously.

After discussion, a motion was made by Councilmember Kells to adopt Resolution 19-21 Approving Appeal Of Variance Decision By The Board Of Appeals And Adjustment for 307 Pleasant Street. Second by Councilmember Bruss. Motion passed 3-2. Councilmember Szaroletta and Mayor Lein voting no.

d. Resolution 19-22 Approving 2020 Budget

Administrator Dickson reviewed the 2020 Budget in detail with the Council during the 6:00 Special Meeting. After thorough discussion, Councilmember Bruss made a motion to adopt Resolution 19-22 Adopting the 2020 Budget for all General, Enterprise and Capital Investment Activities. Second by Councilmember Szaroletta. Motion Carried unanimously.

e. Resolution 19-23 2020 Final Levy

Councilmember Kells made a motion to adopt Resolution 19-23 - Adopting Final Tax Levy Collectible for 2020 at \$1,442,297.00. Second by Councilmember Bruss. Motion carried unanimously.

f. Resolution 19-24 Ordinance 161-O

Administrator Dickson reviewed the proposed changes to the 2020 Fee Schedule with Council. After discussion, Councilmember Bruss made a motion to adopt the fee schedule in Resolution 19-24 Approving Publication of Ordinance 161-O by Title and Summary. Second by Councilmember Lenzen. Motion carried unanimously.

g. City of Cologne Windows 10 Upgrade

Administrator Dickson reviewed his memo to the Council regarding the need to upgrade workstation computers to Windows 10 as the current version of Windows 7 is no longer supported. Motion by Councilmember Bruss to approve the Windows 10 upgrade from TechStar at a cost not to exceed \$14,000. Second by Councilmember Kells. Motion carried unanimously.

h. 2020 City Council and Planning Commission Schedule

After discussion a motion was made by Councilmember Kells to adopt the schedules as presented. Second by Councilmember Lenzen. Motion carried unanimously.

i. 2020 City of Cologne Holidays

Motion by Councilmember Kells to adopt the City of Cologne Holiday Schedule as presented. Second by Councilmember Szaroletta. Motion carried unanimously.
