1. CALL MEETING TO ORDER & ROLL CALL

Mayor Lein called the meeting to order at 7:00 PM. Councilmembers Bruss, Kells, Lenzen and Szaroletta were all present. Also present, City Administrator – Jesse Dickson, City Clerk – Michelle Morrison, City Engineer Jake Saulsbury and Doug Green of Baker Tilly.

Motion by Councilmember Szaroletta to adopt the agenda, second by Councilmember Bruss. Motion carried unanimously.

Motion by Councilmember Kells to adopt the consent agenda, second by Councilmember Szaroletta. Motion carried unanimously.

6. COUNCIL BUSINESS

a. PUBLIC HEARING: Sale of Bonds for 2020 Street Reconstruction

The Public Hearing was declared open for the Sale of Bonds for the 2020 Street Reconstruction Project. Doug Green of Baker Tilly explained the state statute covering Bond Sales and the proposed timeline and process going forward with the sale. Mayor Lein asked if any member of the public wished to speak. Hearing no one, a motion was made by Councilmember Szaroletta to close the Public Hearing, second by Councilmember Bruss. Motion carried unanimously.

b. Street Reconstruction Award Letter

City Engineer Jake Saulsbury, of Bolton and Menk, reviewed the 5 bids that were received for the Street and Utility reconstruction project. The engineer's estimate based on the bidding documents was \$5,100,000. The bids received ranged from \$4,740,909.92 to \$6,099,617.31. The low bidder, GMH Asphalt has completed similar projects and is a responsible contractor. Mr. Saulsbury recommended that the city award a contract to GMH Asphalt. After discussion, a motion was made by Councilmember Kells to award a contract to GMH Asphalt in the amount of \$4,740,909.92, second by Councilmember Szaroletta. Motion carried unanimously.

c. Resolution 20-07 Sale of 2020A Reconstruction Bonds

Motion by Councilmember Bruss to adopt Resolution 20-07 Adopting Street Reconstruction Plan and Approving the Issuance of General Obligation Bonds, Second by Councilmember Szaroletta. Motion carried unanimously.

7. BOARD REPORTS

Mayor Lein provided the Council an update on what actions the City and County have taken in response to the Covid-19 Pandemic.

Councilmember Kells shared concerns he had heard about the opening of the Shack the prior weekend with sale of food and concerns that social distancing was not being practiced as the Governor has requested. After discussion, the consensus was that the operation of the Shack could happen again the weekend of April 18 if the following

restrictions were met: 1) Orders would be phoned in and only served with a runner dropping off food to customers who must stay in their vehicles and 2) No beer sales would be allowed. Mayor Lein stated he would share this with Mr. Pexa.
