Motion by Councilmember Bruss to adopt the consent agenda, second by Councilmember Szaroletta. Motion carried unanimously.

6. COUNCIL BUSINESS

a. Scott Loomis - Construction Hours Extension Request

Administrator Dickson shared with the Council that Loomis construction would like to take advantage of the good weather and get prep work done for the Winkler Crossing development. Currently Ordinance limits weekend construction to the hours of 9 AM to 9 PM, Loomis would like to begin work at 8:00 AM. Councilmember Bruss made a motion to allow Loomis to work from 8:00 AM to 9:00 PM on weekends through December 15, 2020, second by Councilmember Szaroletta. Motion carried unanimously.

b. Cable TV Franchise Agreement

Administrator Dickson covered the Cable TV Franchise Agreement and ordinances with the Council, noting that there will be minor language changes concerning Right-of-Way use that the City Attorney will approve. Motion by Councilmember Bruss to approve both Ordinance 169 and 170 after lawyer reviews the new language in Section 2 regarding Right-of-Way use, second by Councilmember Bruss. Motion carried unanimously.

c. Baker Tilly Water, Sewer, Stormwater Rates Study

Administrator Dickson reviewed the engagement letter and scope of work to be done in a rate study, noting that the last study was in 2012 and should be done every 8 years. Motion by Councilmember Bruss to move forward with the Water, Sewer, and Stormwater Rates Study. Second by Councilmember Szaroletta. Motion carried unanimously.

d. 218 Lake Street W IUP Non-Compliance

Administrator Dickson advised Councilmembers that there are several items in the IUP for 218 Lake St W that have not been completed or adhered to. Options were discussed and staff was given approval to notify the property owner and tenant of their noncompliance and potential withdrawal of the IUP.
