# i. WWTF Upgrade

Mr. Saulsbury provided an update to the Council on the need to upgrade the existing Wastewater Treatment Facility as the Phosphorus limits as set by the MPCA are being reached. The plant was originally built in 1963 and upgraded in 1995. Applications have been made to the PFA for a low interest loan and for Point Source Implementation Grant funds. The design is for a mechanical treatment plant that is designed to be added on to as the city grows. Next steps in the process include soil borings, preliminary design, site layout, and MPCA permitting. Motion by Councilmember Bruss to authorize the next steps in the project at a cost not to exceed \$350,000, second by Councilmember Kells. Motion carried unanimously.

# b. Res No 21-13 Cologne World School Bond Public Hearing

Administrator Dickson advised the Council that the city was contacted by the World Charter School in Chaska to facilitate the issuance of a Bond, the city will be compensated for its work in helping. The public hearing will be held on September 20<sup>th</sup>. Motion by Councilmember Bruss to approve resolution 21-13, second by Councilmember Lenzen. Motion carried unanimously.

Administrator Dickson reviewed the process and bids received to replace the city street sweeper. Motion by Councilmember Kells to accept the quote from Environmental Equipment and Services at a cost not to exceed \$167,950.00, second by Councilmember Bruss. Motion carried unanimously.
