- 1) Replacing item 4 with "The north side of the property will have a screened fence as depicted in the site plan no later than July 31, 2022".
- 2) In item 7 changing the number of vehicles allowed from 10 to 12.
- 3) In item 19 changing the termination date from July 6, 2026 to July 31, 2033 After discussion, Councilmember Bruss made a motion to adopt Resolution 21-21 Amending IUP 218 Lake St W with the changes discussed, second by Councilmember Lenzen.
