SUBJECT: Downtown Redevelopment Plan

Background:

The City Council tasked the Planning Commission with determining the scope of work for a Downtown Redevelopment Plan. In order to provide some insight into what the scope of a plan may entail, links to examples from various cities will be provided below. Prior to creating a plan, the area that is being guided must be defined.

The City currently is operating under the guidance of the 2040 Comprehensive Plan and is also nearing the finishing stages of the Cologne Area Transportation Study. Any determinations made through the process of a downtown plan will need to be made with consideration to those and any other instruments the City uses. Ideally, a new plan is not finalized until the transportation study is complete, which should be this fall.

Planning Commissioner Jenn Brewington provided a list of other considerations for the group:

- Do we have a budget to develop a plan?
- Who will lead the project?
- How much community outreach is needed? What types of outreach?
- What is the timeline for the plan and its implementation?
- What are the goals/priorities? (more businesses, housing, etc.)

While everything can't be figured out in one meeting, determining the area being studied/redeveloped and a timeframe will be key to beginning the project. Community outreach should be considered when planning a timeframe. More meetings will add time and cost; identifying which groups of people are targeted for including in the project will be helpful.

After creating a scope of work and determining a budget in coordination with the City Council, the City can make a determination on utilizing an RFP to find a firm to create the document or work directly with a firm if there is a preference based on example plans.
