## i. Fritz Field Shelter

Mayor Lein reviewed the proposed shelter that the Cologne Hollanders have purchased and would like to locate on Fritz Field. The primary use is for extended batting practice. The location and size were discussed, a permit is currently under review at MetroWest Inspection Services. The assembly and monthly maintenance checks as required in the assembly book would be the responsibility of the Hollander Base Ball Team. There is no electricity to the structure and no lights. After discussion Councilmember Kells made a motion to approve the Fritz Field Shelter subject to the permit being approved by MetroWest Inspection Services, second by Councilmember Lenzen. Motion carried unanimously.

#### ii. 2024 Sheriff's Contract

Administrator Dickson reviewed the proposed contract with Council noting 2024 will have increased police coverage and the budgeted amount will also go up \$60,000. After discussion Councilmember Bruss made a motion approving the 2024 Sheriff Contract, second by Councilmember Szaroletta. Motion carried unanimously.
